Allen made a motion to approve today's **agenda**, seconded by Scheffler. Voting aye were Allen, Scheffler and Cross.

Scheffler made a motion to approve the **minutes from the June 27, 2016 regular meeting and the July 1, 2016 special meeting.** Allen seconded the motion. Voting aye were Scheffler, Allen and Cross.
