

MINUTES OF THE REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF BLAINE COUNTY, STATE OF OKLAHOMA, ON JANUARY 19, 2021, IN WATONGA, OKLAHOMA.

The Blaine County Board of Commissioners met with the following members present: Brandon Schultz, Chairman; Mike Allen, Member; Raymond Scheffler, Member; and Jennifer Haigler, County Clerk.

The advance public notice for the meeting was posted on three exit doors to the Courthouse and in the County Clerk's Office on January 15, 2021, at 9:00 A.M.

Allen made a motion to **approve agenda and amending to include vendor name on item #10 and changing the wording on item #11 to state outfitting a command truck.** Scheffler seconded the motion. Voting aye were Allen, Scheffler, and Schultz.

Scheffler made a motion to approve the **minutes from the January 11, 2021** regular meeting. Allen seconded the motion. Voting aye were Scheffler, Allen, and Schultz.
