Allen made a motion to approve the **application for access drive permit for Continental Resources located from Watonga, head west on US 270 for 6.96 miles and turn left onto N 2500 RD; head south for 7.0 miles and turn right onto E0880 RD heading west for .44 miles to the proposed access road; Section 35, Township 15N, Range 13W-District #1**. Scheffler seconded the motion. Voting aye were Allen, Scheffler, and Schultz.

Allen made a motion to approve the **application for road crossing permit for Tetra Technologies located beginning at the NE/4 of Section 34, Township 15N, Range 13W two lines running for approximately one mile adjacent to the south side on 880 from 2500 to 2490 and additionally adjacent to the north side of American Horse Lake ending at the NE/4 of Section 35, Township 15N, Range 14W-District #1**.
