The Blaine County Election Board met in a SPECIAL meeting at 4:45 p.m., in Basement Room 6 of the Blaine County Courthouse. Advance notice of the meeting was performed by filing a written notice with the County Clerk on July 17, 2017 at 10:03 a.m. and by posting an agenda at the County Election Board office on August 16, 2017 at 9:11 a.m. One copy each of the notice and agenda is attached.

The following members were present: Mike Russell Chairman; Lana Melchor, Vice-Chairman and Brenda Rice, Secretary. Jana Loewen, Clerk, and Robert Cancemi, deputy was also present. Mr. Russell called the meeting to order at 4:45 p.m.

## BUSINESS CONDUCTED AT THE MEETING

- **1. BUSINESS CONDUCTED**: Discuss and approve the minutes for the meeting held September 12 approved. Mrs. Melchor moved that the minutes of the meeting held on September 12, 2017 be approved.
