RESOLUTION

WHEREAS, the Blaine County Board of Commissioners have been granted authority over the county highway system of Blaine County pursuant to O. S. § 69 – 101(g) and;

WHEREAS, the Blaine County Board of Commissioners are responsible to plan, develop, operate, maintain and protect the county highway facilities of Blaine County, for present as well as for future use and;

WHEREAS, it is deemed necessary and in the public interest to establish policy and requirements of obtaining permits for the construction of drives needed for safe access to and from Blaine County roads and;

WHEREAS, prior to construction of any access drive a permit shall be secured from the Blaine County Board of Commissioners. The request for such access drive permits shall be accompanied by a drawing showing the location of the proposed access drive, vehicle use, drive dimensions, drainage pipe (area opening and length) and;

WHEREAS, at the time of filing the application for an access drive permit, the Commissioner for the district in which the access drive is located must be contacted and notified of the intent. This requirement must be met for all access drive permits, including private, public utility, agricultural, etc. and;

WHEREAS, for the installation of any access drive without first securing a permit, the party of parties in violation of this adopted policy shall be assessed an administrative penalty of up to Ten Thousand Dollars (\$ 10,000.00) plus any damage or costs due to the installation of the unauthorized and/or non-standard access drive. No future permits shall be issued until all costs, damage repair and other requirements of these rules and regulations have been met to the satisfaction of the Blaine County Board of Commissioners and;

THEREFORE, let it be resolved that the Board of Commissioners of Blaine County has met in regular session this 4th day of August, 2014, and has adopted the above policy.
